Dear Sir,

Uttarakhand Renewable Energy Development Agency (URED) as per the clause 15(d) of the Energy Conservation Act 2001 has been designated as the State Designated Agency (SDA) to coordinate, regulate and enforce provisions of the Act within the State of Uttarakhand. Under section 14(p) of the Energy Conservation Act, 2001, Central Government has powers to prescribe ECBC norms for non-residential buildings. The state government has the flexibility to modify ECBC to suit local or regional needs. All the commercial buildings having conditioned area 500m² and above are liable to comply Uttarakhand Energy Conservation Building Code (ECBC).

The Energy Conservation Building Code (ECBC) set minimum energy performance standards for design and construction of commercial buildings. The adoption of ECBC will save around 30-40% of energy demand of the building that will not only save the monetary energy of the buildings but also reduce the electricity demand – supply gap of the state and carbon emission to the environment. For implementation of this, a fair knowledge on ECBC (Energy conservation building code) & ENS (Eco Niwas Samhita) and its compliance is required for concerned Government officials, Engineers, Architects, building design professionals etc.

To achieve the objective of capacity building amongst concerned Government officials and professionals, UREDA with the support of **Bureau of Energy Efficiency (BEE), Government of India**, is organizing series of capacity building programs for the concerned Government officials, practicing Engineers, Architects and building design professionals of the state. In view of above, UREDA is organizing **Half day on-line training on Awareness for ECBC & ENS in Google Meet on 14th of October, 2022..**
